City of Raleigh will pay for our mid-year letter as a benefit to belonging to the Raleigh Community Registry, as long as we get it to them well in advance.

- b. Social Jaime Weathersby wasn't in attendance, but it was discussed that the Spring Fling is coming up and the Social Committee has been busy preparing.

5. Old Business

- a. Emergency Pool Phone Board discussed the proposed 911 pool phone. There were concerns that children, for example, would try to dial home and the phone would only call 911, and they then hang up, officers are still dispatched to investigate. If there are frequent calls to 911 HMW will be charged for those officer calls. A motion was introduced and seconded to keep the existing phone system. The motion carried.
- b. Neighborhood Registry Ron Alford spoke with the City of Raleigh representative, Kevin Smith. He felt that the proposed project, supplementing the area behind the pool, could be considered for the matching funds. Ron and Don Nelson will work on the proposal. There is a May, 2016 deadline.

6. New Business

- a. Landscaping one of our homeowners with his own landscaping firm, DR Lawn, is interested in bidding for this work. David Hurst will discuss with Mark and provide a proposal to the board.
